

Eagle Rank Requirement Two: Eagle References CROSSWINDS Eagle Board updates: Revision 20090809.01

An “Eagle reference” is defined as the name, address, city, state, zip and ten digit phone number of a person who the Eagle candidate has personally contacted and authorized them to provide conduct and character information to the District Eagle Board of Review (DEBOR).

Each Eagle candidate is required to *PROVIDE* five Eagle references on his Eagle Scout rank application. If the candidate is currently employed outside of his home, he must *PROVIDE* a sixth reference in the Employer line of requirement 2 on the Eagle Scout rank application. The five required Eagle references are: Parental, Religious, Educational, Other1, and Other2. “Other(x)” Eagle references are any other adults not related to the Eagle candidate and/or not a registered member of his specific Scouting unit. Adult Scout leaders from other units may be listed as an Eagle reference.

If the Eagle candidate is not a member of an organized religious institution, his parent(s) must provide the Religious Eagle reference, stating that the family has no church affiliation at this time and outlining the reason(s) why. The letter should state whether or not the scout has a belief in a Supreme Being, and how he fulfills his Duty to God in his daily life. In this exception case, the Parental Eagle reference and the Religious Eagle reference may be combined, but the Eagle reference information *shall* be on BOTH the Parental and the Religious lines, in requirement two of the Eagle Scout rank application.

Once the Eagle candidate provides the Eagle references on his Eagle Scout rank application, he has completed requirement two of the Eagle rank. **Unit Scout leaders SHALL NOT sign the application until the Eagle candidate has provided the required Eagle reference information on the Eagle Rank Application.** The Eagle Service Desk will refuse to accept any application that is missing the required five (or six) Eagle references.

If the Eagle reference providers listed on the Eagle Rank application do not submit the requested information, the DEBOR cannot require the Eagle candidate to make follow-up contact with those providers or submit different Eagle reference information. Furthermore, the Eagle candidate cannot have a board of review denied or postponed because the council office or council advancement committee does not receive the references he requested from the individuals listed on his Eagle Scout rank application.

All Eagle related paperwork SHALL be turned into the Council office by the 25th day of each month to be guaranteed a final review on the second Wednesday of the following month.

The Eagle reference providers may provide the requested character information in one of three methods:

1. A letter mailed to the Eagle Service Desk:

The email shall not be copied (or blind copied) to any other recipients.
The Subject: of the email should be formatted to include:

3. A personal phone call interview, initiated by the Chairman of the DEBOR
In Crosswinds District, all phone interviews will be documented on a “call review form” and included in the Eagle candidate’s packet of information you will be given to evaluate.
